(MACE) have entered into a Memorandum of Understanding (MoU) with the Collector, Madhepura District, Bihar, to support the rehabilitation and reconstruction activities in Pattori Gram Panchayat, Singheswar Block, Madhepura District of Bihar for those ravaged by the Kosi floods last year. The Mahindra Foundation will provide a sum of Rs. 3.29 crore towards this activity. Both Mahindra employees as well as the Management contributed to this amount.

The Collector of Madhepura District, Bihar will provide the land required for the purpose of construction of the permanent houses to Mahindra Foundation & MACE.

These houses will be built in this model village, which was ravaged by the Kosi river last year. These will be constructed in accordance with the type, design and habitat layout of such quality as approved by the District Collector in consultation with the beneficiaries and will be based on the overall technical guidelines for disaster resistant buildings specified by the Department of Planning and Development.
